BOOKINGS: To secure your date(s)/time(s) for bridal/non-bridal bookings a retainer/deposit is required. The deposit is non-refundable and non-transferable. You may e-transfer the funds to info@jiyaahmad.com or arrange a time & date to drop it off to said location. Only once the deposit is received will your booking be confirmed.

CANCELLATION POLICY: Cancellations can be made up to 60 days before the event date without any extra charges.

If a cancellation is made 30 days prior to your event date, 50% of the total contract amount will be charged.

If a cancellation is made with in less than 30 days to your event date you will then be charged 100% of the total contract amount. This includes no shows and missed appointments, with or without completed service.

Once the retainer is received, number of services stated cannot be reduced, services can be added depending on the availability of the artist.

LIABILITY: All brushes and makeup products are kept sanitary. All products are sanitized between every makeup application. Any skin condition should be reported by the client to the Artist prior to application, and if needed a sample test of makeup may be performed on the skin to test reaction sudden reactions to skin or hair on the time of application, the artist will be not be responsible.

Ample time is given for each service upon booking. However artist will not be held responsible for unfinished Makeup/Hair due to late client or for "suggestive satisfaction" or for unrealistic expectations. Expectation example: client provides photo of model with different hair color, length,

texture, skin tone & texture, eye color etc - reasonable effort will be made to get as close to the overall look as possible. Artist(s) can not be responsible for any makeup/hair issues after artist(s) have left. This includes veil placement/removal client adding makeup to their face, lipstick wearing off etc. Clients requesting use of any of their personal beauty product releases artist of any satisfactory guarantee service.

Excessive touching of hair and makeup, kissing, drinking from a glass, excessive crying, excessive sweating etc. are all factors in determining the longevity/lasting of makeup and hair.

FORCE MAJEURE: Jiya Ahmad reserves the right to reschedule and/or cancel in the event of a Force Majeure/"Act of God" (earthquakes, fires, floods, snow storms, ice storms etc.) catastrophic travel disruption (road closures, flight delays/cancellations, car accidents etc.) or in the event of incapacitation (major illness or death).

CONSENT: I hereby consent and authorize the use of any photographs/video taken by Jiya Ahmad and it's employees to be used for promotional use (e.g social media, portfolio, website) without limitation and or remuneration. You may request that no photo/video be taken.

DELAYS: It is imperative that clients inform the artist ahead of time of any delays that might occur due to traditions etc. for one-day events as well as any time restrictions so that they can be accounted for ahead of time.

Please note we are typically booked back to back and we do not have the flexibility to honour late clients.

In the event that a client is later then 20 minutes for their scheduled appointment they risk having their appointment cancelled along with the forfeiture of deposits already paid and/or a minimum \$40 late fee.

PAYMENT:

All balance dues are to be made in cash & in person on the day of the event. Only deposits can be made through e-transfer prior to your event dates. The final balance is due on the day of the event as one payment to the Artist. **The person(s) responsible for the entire payment is the person(s) who has signed/agreed to the contract. For large parties it is suggested that one designated person collect the entire balance and pay it to the Artist. The Artist is not responsible for collecting balances due in portions from individual clients.**
